It was great to meet with you and Amber today. I'm very glad that we did not discover a breakout of the trench.

I am attaching an updated map of that oak wilt center titled Hatley- Oak Wilt Map 2021. As we discussed anyone within this trench line and less than about 150 feet from the red area may wish to consult with an arborist regarding fungicide injections. I have also attached an overview of the oak wilt centers and trenches that I am aware of in Rollingwood titled Rollingwood-Oak Wilt Map. I want to stress that much of information in this particular map may be dated, and that some of these oak wilt centers may no longer be active. 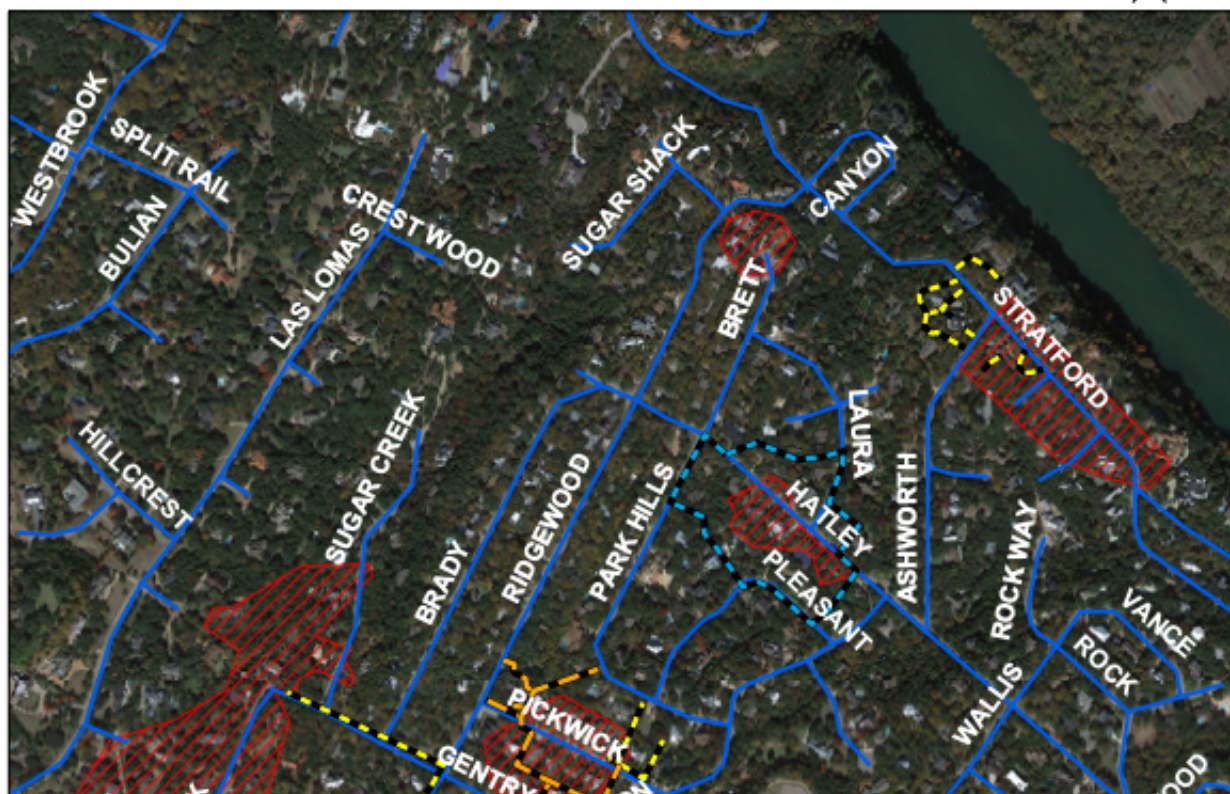
