DISCUSSION AND POSSIBLE ACTION FOR CALLING A SPECIAL MUNICIPAL ELECTION ON NOVEMBER 4, 2014 TO ELECT TWO (2) ALDERPERSONS WHO WILL SERVE ON THE CITY COUNCIL TO FILL VACANCIES FOR THE REMAINDER OF TWO EXISTING TERMS ENDING NOVEMBER 2015

Alderman Basham moved to call the <u>General Election</u> and the <u>Special Election</u> on November 4, 2014, the motion was seconded by Mayor Pro Tem Hutson, the motion passed 4 to 0.
