

STANDING JUDICIAL ORDER
COMPLIANCE DISMISSALS

IT IS ORDERED that the Court Clerk may process for dismissal, after proof of compliance as required by law, offenses outlined on the attached Compliance Dismissals chart.

A. COMPLIANCE DISMISSALS WITH \$20 DISMISSAL FEE

Pursuant to state law, the following offenses may be dismissed by the Court upon compliance with the law and a \$20 dismissal fee:

1. Expired Motor Vehicle Registration
2. Expired Motor Vehicle Inspection (offense committed prior to March 1, 2015)
3. Expired Driver's License
4. Fail to Report Change of Address or Name
5. Expired Disabled Parking Placard (offense committed after September 1, 2009)

B. COMPLIANCE DISMISSALS WITH A \$10 DISMISSAL FEE

Pursuant to state law, the following offenses may be dismissed by the Court upon compliance with the law and a \$10 dismissal fee:

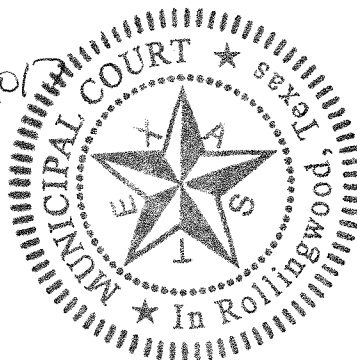
1. Display Altered, Unclean, or Obscured License Plates
2. Violate Driver's License Restriction or Endorsement
3. Defective Equipment
4. Operate Motor Vehicle Without Registration Insignia
5. Operate Motor Vehicle Without Two License Plates
6. Displaying License Plate or Registration For Period Other Than in Effect


C. DISMISSAL PROCESS

1. Court Clerk shall make appropriate comments in the computer system;
2. Date stamp and make a copy of the documents for the file establishing proof of compliance;
3. Present the documents and case file to the Judge for dismissal

**STANDING JUDICIAL ORDER
FINES AND PAYMENT OF FINES**

IT IS ORDERED that on this date with respect to fines and the payment of fines:

A. FINE SCHEDULE

The attached Fine Schedule ("Window Fines") shall be assessed at the Court Clerk's window upon a plea of GUILTY or NO CONTEST to the stated offenses unless individually adjusted by the Court or imposed pursuant to a jury verdict.

B. LATE APPEARANCE

If the defendant fails to appear in compliance with the citation or summons, the Court Clerk shall process a FINE INCREASE of \$50 on the day following the 10th business day after the required appearance date.

C. EXCEPTIONS

This applies to all charges filed with the Rollingwood Municipal Court except for offenses committed by JUVENILES and the offenses of FAILURE TO APPEAR and VIOLATE PROMISE TO APPEAR.

D. MAILBOX RULE

The fine increase shall be removed by the Court Clerk only upon proper application of the "Mailbox Rule" in Texas Code of Criminal Procedure Article 45.013.

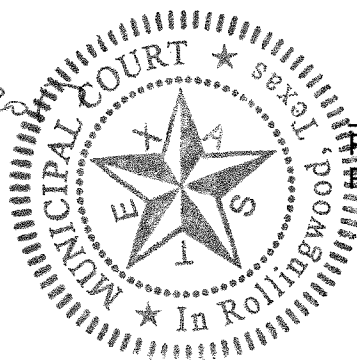
E. PAYMENT OF FINES AT CLERK'S WINDOW

The following requirements apply to the payment of fines, fees, and costs at the window:

1. GENERAL RULE: The Court Clerk may accept payment of fines, fees, and costs at the window in accordance with Texas Code of Criminal Procedure Article 27.14.
2. PLEA: If no judgment has been entered by the Court, the Court Clerk must receive a plea of guilty or no contest in writing and signed by Defendant or Defendant's Attorney before accepting payment of a fine, fee, or cost.
3. VERIFICATION OF IDENTITY: Before accepting a plea of guilty or no contest, the Court Clerk shall verify and record the identity of the person entering the plea. If no sufficient identifying information can be obtained, the person must appear in open court. The following identifiers shall be sufficient:
 - (a) Government issued photo identification card
 - (b) Driver's License
 - (c) Passport

STANDING JUDICIAL ORDER
DRIVING SAFETY COURSE

IT IS ORDERED that on this date with respect to dismissal of a case by means of a Driving Safety Course:

A. PROCESSING A REQUEST FOR DRIVING SAFETY COURSE AT CLERK'S WINDOW

The Court Clerk shall process a request for a Driving Safety Course (DSC) or Motorcycle Operator Training Course (MOTC), as applicable, if Defendant is charged with an eligible offense as defined in Texas Code of Criminal Procedure Article 45.0511 and meets the following requirements ON OR BEFORE THE ANSWER DATE on the notice to appear:

1. submits in person, through counsel, or by certified mail, return receipt requested, postmarked on or before the answer date, a request to take the course;
2. enters a plea of no contest or guilty;
3. presents a valid Texas driver's license or permit that is not a commercial license or permit;
4. provides valid proof of financial responsibility;
5. submits an affidavit as set forth by Sec. 45.0511(c)(3) of the Texas Code of Criminal Procedure stating that Defendant is eligible to take DSC or MOTC;
6. pays at the time of the request court costs and fees authorized by law in addition to an administrative fee of \$9.90 authorized by Sec. 45.0511(f)(1) of the Texas Code of Criminal Procedure.

B. PROOF OF COMPLIANCE

The following requirements apply to dismissal of the case upon proof of compliance:

1. **COURT CLERK MAY ACCEPT DOCUMENTS:** The Court Clerk may accept proof of completion of DSC at the window or by mail if the Defendant presents:
 - (a) A certificate indicating timely completion of the DSC or MOTC course as applicable, which must be signed by the Defendant, indicate that it is the "court copy," and have no alterations or modifications; AND
 - (b) A driving record certified by the Texas Department of Public Safety, issued after the offense date, that indicates Defendant has not completed a driving safety course or motorcycle operator training course, as applicable, within the twelve (12) months preceding the date of the offense.
2. **DISMISSAL PROCESS:** If the Court Clerk receives sufficient proof of completion of the requirements as outlined above within ninety (90) days of the date of the request, the Court Clerk shall:
 - (a) Make appropriate comments in the computer system; AND
 - (b) Send the case to the judge for dismissal.

C. FAILURE TO COMPLY

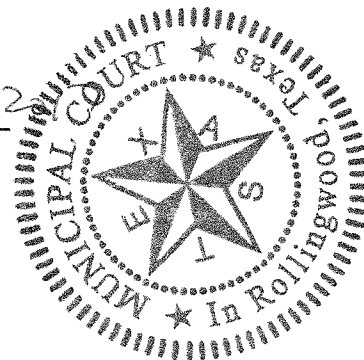
If a Defendant requesting a course fails to comply with the requirements and provide evidence of successful completion of the DSC or MOTC, as applicable, within the time allowed, the Court Clerk shall:

1. NOTICE: notify the Defendant in writing mailed to the address on file with the court or appearing on the notice to appear, of that failure; AND
2. SHOW CAUSE HEARING: require Defendant to appear in court and show cause why the evidence was not timely submitted to the Court. If the Defendant fails to appear at the show cause or appears and does not show good cause for the Defendant's failure to comply, the Court Clerk shall process a judgment of conviction and the Court shall enter an adjudication of guilt and impose sentence.
3. CONVICTION: The Court Clerk shall notify the Defendant that a conviction has been entered and that they have a 30 day extension to pay the balance in full.

This Order supersedes any conflicting previous standing orders concerning DSC and MOTC.

STANDING JUDICIAL ORDER
APPEARANCE AND DOCKETS

On this date, the Court entered the following ORDER with respect to appearances and dockets:

A. APPEARANCE

1. **IN PERSON:** A Defendant is considered to have entered an appearance and will be set on the Initial Appearance or Pre-Trial Docket if the Defendant submits photo ID, or is able to be identified by the Court Clerk in person, and submits a request for action in their case.
2. **MAIL OR FAX:** A Defendant is considered to have entered an appearance and will be set on the Initial Appearance or Pre-Trial Docket if the Defendant submits the above required documents with a signed request.

B. ATTORNEYS

An attorney who makes an appearance for a Defendant shall file a Letter of Representation with the Court Clerk clearly indicating such entry of appearance and requesting that the case be set on a docket. The letter must contain the following:

1. Defendant's full name;
2. Defendant's date of birth;
3. Defendant's driver's license number, if known;
4. The case number and offense name of each charge on which the attorney is appearing.

C. DOCKET SETTINGS


The following requirements apply to docket settings:

1. **APPEARANCE:** The Appearance Docket shall be scheduled if the Defendant requests to speak to the Judge, the Defendant is appearing in compliance with a citation or summons, or the Defendant has failed to make an initial appearance.
2. **PRETRIAL:** The Pretrial Docket shall be scheduled upon any plea of not guilty or upon a plea of not guilty if the Defendant wants to discuss the case with the prosecuting attorney. A Defendant may, at or after the Pretrial Conference, request to proceed to trial by Judge or Jury.
3. **JUVENILE:** The Juvenile Docket shall be scheduled for all juvenile cases.
4. **SHOW CAUSE:** The Show Cause shall be scheduled for all cases in which a show cause hearing is required by law.
5. **PAYMENT REVIEW:** The Payment Review Docket shall be scheduled for all cases for inability to pay, to determine indigent status, following default in payment, or other hardship after entry of judgment.
