AN ORDINANCE AMENDING ORDINANCE NO. 2011-09-29, ADOPTING AND APPROVING AN AMENDED BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2011 AND TERMINATING SEPTEMBER 30, 2012, PROVIDING FOR THE PROCEEDS OF THE SALE OF GENERAL OBLIGATION BONDS AND USE OF SUCH PROCEEDS FOR ACQUISITION OF THE CITY'S WASTEWATER SYSTEM, EXPENSES ASSOCIATED WITH THE ISSUANCE AND SALE OF BONDS AND ACQUISITION OF THE SYSTEM, AND IMPROVEMENTS TO THE SYSTEM

Except as specifically affected by the appropriations reflected on the attached Exhibit "A," the budget for fiscal year 2011 - 2012 shall remain in full force and effect.
