ORDINANCE NO. 2012-11-14

AN ORDINANCE OF THE CITY OF ROLLINGWOOD, TEXAS, AMENDING SECTION Sec. A8.001 (PARK PAVILION FEES) OF APPENDIX A TO THE CITY OF ROLLINGWOOD CODE OF ORDINANCES TO AMEND THE FEES APPLICABLE TO USE OF THE PARK PAVILION; PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE

WHEREAS, as a result of various scheduled sporting and social events in the City park, the park is periodically excessively crowded;

WHEREAS, there are insufficient parking facilities for the level of use made of the City park, resulting in crowded streets and unlawful parking in the residential areas surrounding the City park;

WHEREAS, the park pavilion has become a popular location for private parties and social events for users throughout the region, resulting in overcrowding in the park and congestion on the streets in residential areas surrounding the park;

WHEREAS, the reservation of the park pavilion by residents of the City is relatively infrequent;

WHEREAS, the City is amending its rules to provide that non-residents of the City may not reserve the park pavilion for private use; and

WHEREAS, the fee schedule for use of the park pavilion must accordingly be amended,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROLLINGWOOD, TEXAS:

Section 1. Sec. A8.001 (Park pavilion fees) of Appendix A to the City of Rollingwood Code of Ordinances is amended to provide as follows:

Sec. A8.001 Park pavilion fees

- (a) Reservation fee (resident of the city): No fee.
- (b) Resident deposit fee: \$100.00, which fee may be applied to pay the cost to repair any damage occurring during the period of use and/or to clean the area in the event of excessive litter or debris.
- **Section 2.** Completed reservations of the park pavilion by those who are not residents of the City that are in effect on the date this Ordinance shall remain effective and subject to the fees in effect prior to the date of this Ordinance. No new reservations of the park pavilion by those who do not reside in the City shall be made from and after the date of this Ordinance.

Section 3. This Ordinance shall be effective immediately upon adoption.

Section 4. If any provision of this Ordinance is found by a court of competent jurisdiction to be void or unenforceable, such void or unenforceable provision shall be severed as though it never formed a part of this Ordinance, and all other provisions hereof shall remain in full force and effect.
