

**CITY OF ROLLINGWOOD, TEXAS**  
**ORDINANCE NO. 2017-10-18 (B)**

**AN ORDINANCE OF THE CITY OF ROLLINGWOOD, TEXAS, AMENDING  
APPENDIX A OF THE CITY CODE OF ORDINANCES TO PROVIDE FOR FEES  
PAYABLE FOR VARIOUS FOOD SERVICE INSPECTIONS AND PLAN REVIEWS,  
PROVIDING AN EFFECTIVE DATE, AND SEVERABILITY**

WHEREAS, pursuant to that certain Interlocal Cooperation Agreement with the City of Austin dated September 26, 2013 for the provision of various food service inspection and development review services, the city has agreed to maintain fees for such inspections and development reviews that match the fees for the same performed by the City of Austin in the City of Austin; and

WHEREAS, the city desires to adopt the applicable fees, which are determined to be fair and reasonable, and to pass on to the City of Austin the fees payable by applicants for inspections and plan reviews in the City of Rollingwood,

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROLLINGWOOD, TEXAS:**

**Section 1.** City Code of Ordinances Appendix A, (“**Appendix A**”) Fee Schedule, Section A6.000 is amended to provide as follows:

- (a) Alcoholic beverage permit: 1/2 fee imposed by state.
- (b) (Reserved)
- (c) Fire prevention inspection: \$27.50.
- (d) Massage establishment fee: \$110.00.
- (e) Massage operator fee: \$55.00.
- (f) Ham radio fee: \$165.00.
- (g) (Reserved)
- (h) Commercial solid waste permit/year/company: \$110.00.
- (i) Solicitation/six months: \$100.00.
- (j) Food establishment permits and inspections:

**1. Food establishment permit (including food processing plant or warehouse)**

1 to 9 employees      \$310.00

10 to 25 employees    \$425.00

26 to 50 employees    \$620.00

51 to 100 employees   \$805.00

Over 100 employees    \$990.00

Expired Permit Late Fee      \$100

**2. Mobile food unit permit (fee per unit)**

Restricted Operation      \$90.00

Unrestricted Operation      \$210.00

**3. Temporary food establishment permit**

2 calendar days or less      \$35.00/booth

3 -5 Calendar days      \$70.00/booth

6-14 calendar days      \$90.00/booth

Expired Permit fee      \$100.00

**4. Food Establishment Plan Review**

New Construction or Change of Owner:    \$250.00

Remodel of Permitted Facility:

Greater than 10,000 sq. ft.      \$250.00


2,500 – 9,999 Sq. ft.      \$165.00

Less than 2,500 sq. ft.      \$60.00

**Section 2.** This Ordinance shall be effective immediately upon adoption.


